<p>Justice Programme, “Supporting Initiatives in the field of Drugs Policy” – JUST-2017-AG-DRUG</p> <p>The aim of this call is to support projects in the field of drugs policy as regards judicial cooperation and crime prevention aspects closely linked to the general objective of the Programme, in so far as they are not covered by the Instrument for financial support for police cooperation, preventing and combating crime, and crisis management, as part of the Internal Security Fund, or by the third Programme for the Union's action in the field of health (2014-2020).</p> <p>Eligible applicants: Applicants and co-applicants must be legal persons established in the Member States of the European Union, including their Overseas Countries and Territories, without UK and Denmark, public body or a non-profit-making private entity or an international organisation.
